## Privacy Policy

Protecting your private information is our priority. ### Collection of your Personal Information

In order to better provide you with products and services offered on our Site, HDF may collect personally identifiable information, such as your:

If you donate to HDF's programs and services through your credit or debit card, we collect billing and credit card information. This information is used to complete the purchase transaction. We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. ### Use of your Personal Information

### **Sharing Information with Third Parties**

HDF does not sell, rent or lease its donor lists to third parties. HDF may share data with trusted partner organizations to help perform statistical analysis, send you email or postal mail, provide donor support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to HDF, and they are required to maintain the confidentiality of your information. HDF may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on HDF or the site; (b) protect and defend the rights or property of HDF; and/or (c) act under exigent circumstances to protect the personal safety of users of HDF, or the public.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by HDF. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the HDF website.
